Subject China Decree No. 53 – Medical Equipment export inspection

Dear Customer,

In order to enhance the supervision quality of medical equipment exportation, the Chinese General Administration of Customs has enacted Decree No. 53, outlining that for all medical equipment relevant documents for export commodity inspection have to be prepared effective from 10th April.

According to this Decree, the listed materials can only be exported after the completion of the Customs statutory commodity inspection. This requires manufacturers to declare necessary products information to the local Customs. If the Customs need to check the declared goods, it may take more time.

Please find below the commodities on and HS Codes which require export commodity inspection:

You can also access the <u>official website</u> of National Medical Products Administration to search for the registration certificate of the medical device producer (business unit).

Also Hong Kong Customs restricts to truck certain type of PPE (Personal Protective Equipment) cargo such as masks, gloves, disinfectant material etc. from China to Hong Kong, unless there is an authorization letter from the consulate of foreign government.



We would therefore like to highlight the below procedure and request you to stick to this cut-off time to ensure the successful uplifting of your shipment:

- Day -3 noon time, shipment/Export clearance dox/PPE license arrive at DGF warehouse.
- Day -2 afternoon, process export clearance.
- Day -1 whole day, shipment hand over to airline terminal, ULD build up.
- Day 0 whole day, cooling time for irregular solving and so on.
- Day 1 flight uplift.

Example: If the charter/flight will depart on 25 Apr, the shipment/export clearance dox/PPE license must arrive at the DGF warehouse before 21 Apr noon, China Local Time.
